First are the Sisters of the Daughters of Union Veterans with their flags and banners; next, the Sisters of the Woman's Relief Corp, followed by the Ladies of the Grand Army of the Republic, and finally the Sisters of the Auxiliary to Sons of Union Veterans of the Civil War. If there are carriages they will follow at the rear. Period dress was required for many years, but recently, the wearing of street clothing has been permitted, "Sunday Best" is requested. Everyone is required to wear the badge of their order on their coat. There is absolutely NO deviation in the above order of March. This is truly a "Peak Experience" for those who have participated in past years. 2011 NATIONAL ENCAMPMENT VOTES



1. That detailed Job Descriptions for National officers be included in or referenced to in the CR&R.
2. That a committee be appointed to update the CR&R.
3. That the requirement of five new members present for the chartering of a new Auxiliary be dropped to three.
4. That annual reports be limited in time to approximately four (4) minutes for National Officers, three (3) for Department Presidents and two (2) for Committee Chairs. The complete written reports will be submitted in writing for recording purposes.
5. That the office of National Supply Officer be made an elected, rather than appointed office; and that an official job description for the National Supply Officer be established; and that among the duties of the National Supply Officer be the requirement to supply an inventory of the existing supplies on no less than an annual basis.
6. That the Love Token to the Sons of Union Veterans of the Civil War be the only Love Token given by the Auxiliary.
7. That "love tokens" to officers be discontinued immediately.
8. That each office be nominated and elected individually until the entire slate of officers is filled.
9. That no monies, budgeted or otherwise, be dispersed without a proper receipt, including those paid to all officers, elected or appointed.
10. That the dress code for National Officers and Floor Workers be white dresses or skirts below the knee and that the dress code be printed in the CR&R.
11. That the elected position of Supply Officer be a five (5) year term.
12. That all resolutions, changes to the CR&R, and other items of concern to all, be presented to the general membership prior to the National Encampment. Resolutions can be provided via the National website or upon registration.
13. That we will not provide medals for ROTC.
14. Bring back Girl Scout Gold Awards given to Girl Scouts on achieving the highest level in their order. When mailing certificates to Girl Scouts, include history of our Organization, application for membership, and the address and phone number of a member to contact for more information.
15. That the Legislative Committee be removed from the list of Standing Committees and be dissolved until such time comes in the future when legislation affecting women becomes noteworthy and demands our attention.
16. We continue to give a \$400 scholarship to a college student of the National President's choice.
17. We do not raise the per capita tax this year.
18. As most correspondence is done on the internet, we should cut the amount of stationery and envelopes that is given to all officers by half, except for the Secretary and Treasurer, as they do most of the mailing.
19. The office of Budget Director was eliminated years ago as it was of little help to the National Organization, we should uphold that decision.



2011 NATIONAL ENCAMPMENT VOTES (continued)

20. When a Department or the MAL Coordinator knows of a Sister who has left the Order, they should forward her name and address to the National Vice President as soon as possible so she can write a personal note to the Sister.
21. When a Sister reaches the tender age of 90, the National Order will grant her a Life Membership. The National President may award a Life membership earlier under special circumstances.
22. That we go back to tri-cycle Per Capita Tax Reports effective January 1, 2012. This would mean 1st cycle would be January, February, March and April, due May 25th; 2nd cycle May, June, July and August, due September 25th; 3rd cycle September, October, November and December, due January 25th.
23. That no mileage reimbursement be made to any National Officers except for National President, Secretary and Treasurer at the current rate of \$.15 per mile.
24. Auxiliary National President should confer with the Sons Commander-in-Chief to make sure the Chiefs of Staff of the Orders are introduced to each other and are aware of their respective responsibilities for the Joint Opening.
25. Since it is the National President's Personal Aide who is responsible for the President's well being, the job of decorating the room and planning the Courtesy Hour should be done by the Personal Aide with the assistance of the Chief of Staff and Aides.
26. All members with access to e-mail are asked to supply the National Secretary with their email address to enable them to receive their General Orders and the National Proceedings via electronic means.

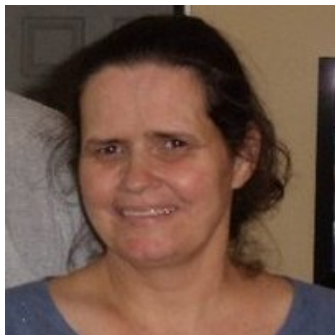

The National President has asked me to try and help clarify the confusion about the EIN #'s and the loss of tax-exempt status. When the IRS started the e-postcard filing system, everyone was directed to go on-line and file. At that time the IRS stated that if you were under a parent organization and they filed, you were good for 3 years. That has now changed, and it is necessary that EACH Auxiliary file their own e-postcard. If you have been notified that you have lost your non-profit status, you will need to reapply for a new one. You can still use your auxiliary name and number. There is a fee for this now, it is no longer free. When you get your new EIN #, be sure to send it to me. Each Auxiliary must do their own e-filing, as it is not something that I can do. If you need help with any of this, please contact me by e-mail and I will assist you.
